D. NEW BUSINESS

1. Approval of March 5, 2025, Lake Banks Committee Meeting Minutes

A **motion** was made by Ms. Milmore, seconded by Dr. Powers approving the March 5, 2025, minutes, amended to reflect the following: substituting the word "community" for "supervisors." The **motion** passed unanimously.

2. Committee Discussion

Dr. Powers gave an overview of the current lake conditions and asked for the next steps. Mr. Gomez responded that he would relay the concerns back to Mr. Matthes.

There was a budget discussion regarding the lake bank restoration project and a recommendation that the Tradition Lake be the first to repair. They would like to see an earmark in the budget for any future lake repairs.

After committee discussion, there was a consensus of the Lake Banks Committee directing the District Engineer to provide a recommendation on the best solution for the worst lakes with detailed costs per linear feet as well as a recommendation for a long-term plan for maintenance and repairs with a timeline by the next meeting.

There being no further business to come before the Committee, Mr. Lasher made a **motion** adjourning the meeting, seconded by Ms. Milmore. Meeting adjourned at 12:00 p.m. There were no objections.
