District Manager, Frank Sakuma called the June 4, 2025, Tradition Lake Banks Committee Meeting to order at 9:00 a.m. in the Tradition Town Hall located at 10799 SW Civic Lane, Port St. Lucie, Florida 34987.

D. NEW BUSINESS

1. Approval of April 2, 2025, Lake Banks Committee Meeting Minutes

A **motion** was made by Ms. Cost, seconded by Ms. Milmore approving the April 2, 2025, minutes. The **motion** passed unanimously.

2. Resignation of Lauren Leandre from Lake Banks Committee

Mr. Sakuma notified the Committee that Ms. Leandre had resigned from the Lake Banks Committee.

3. Committee Discussion

District Engineer Stef Matthes advised that after performing a physical survey of the lank banks he found more issues with the lake banks than initially anticipated.

Mr. Matthes stated that 42 lakes showed signs of lake bank erosion with 7 requiring immediate attention. Mr. Matthes categorized lake repairs from the most to least critical and presented four options with cost estimates. He stated that repairs would cost between \$7 and \$8 Million over an extended period of time. Mr. Matthes suggested creating an Annual Lake Bank Repair Program.

After discussion, there was a consensus of the Committee to recommend establishing an Annual Lake Bank Repair Program and adding a \$775,000 line item to the Tradition CDD Operations and Maintenance section of the budget for lake bank maintenance.

A **motion** was made by Mary Milmore, seconded by Peter Webb authorizing CDD No. 1 to create a Lake Bank Repair line item in the proposed budget amount of \$775,000. The **motion** passed unanimously.

E. COMMENTS FROM THE PUBLIC

There were no comments from the public.

F. ADJOURNMENT

There being no further business to come before the Committee, Ms. Milmore made a **motion** adjourning the meeting, seconded by Mr. Sexauer. The Meeting adjourned at 10:27 a.m. There were no objections.
