E. NEW BUSINESS

1. Consider May 6, 2026, Lake Banks Committee Meeting Minutes

A **motion** was made by Ms. Milmore, seconded by Mr. Lasher, approving the May 6, 2026, minutes, as presented. The **motion** passed unanimously.

2. Committee Discussion

a. Update from the District Engineer

b. Update from the District Engineer

With the assistance of several handouts, Messrs. Matthes and Wilbur reviewed the WMT-A12 Erosion Repair Plan. The discussion of costs evolved and the engineer was asked to bring back a reduced cost option for the next committee meeting to be considered and then offered to the full Tradition CDD 1 board.
